The Applicant should be above 18 years of age as on October 1, 2017. The Applicant will be required to produce their age proof (Passport, birth certificate, school leaving certificate, driver's license, etc.).

- 2. The applicant declares that he/she is willingly participating in the show "Yarri Dostii Shaadi Season 3" ("Show") being produced for NDTV Lifestyle Limited ("NDTV Lifestyle") for broadcast on it Channel, i.e. NDTV Good Times ("the Channel").
- **3.** The Applicant would be required to submit detailed information regarding getting married, the date and the venue of the wedding and any other information that NDTV Lifestyle may require from time to time.
- **4.** Applicant(s) are advised to furnish correct information. Any false information given by an Applicant at any stage will lead to automatic disqualification.
- 5. The story/ies that will be part of the Show will be pre decided mutually between NDTV, the bride/ groom. Once the stories have been agreed upon by the Applicant he/she cannot back out and not do any such pre-decided story. The Applicant has to discuss and inform the respective in-laws about the stories decided for the Show. In case of any objection by the respective families then the Applicant needs to inform the Show team at once and 15 days in advance in writing before the commencement of the shoot.
- **6.** The Show team honors the rituals and traditions of the families as communicated to the team. The Applicant needs to fully and openly give out all details of the rituals prior to the commencement of the shoot to avoid any ambiguity later on.
- 7. In the event an Applicant is chosen to participate and gets featured in the Show, the Applicant will be required to agree to and sign terms and conditions for participation in the Show. Failure/refusal to agree to the terms and conditions shall automatically disqualify an Applicant from participation. It is clarified that such terms and conditions shall be in addition to these rules.
- **8.** The Applicant if chosen for the Show will ensure that he/she will be covered in the Show will need to be available for shooting of the Show for a period of 5 days. The Applicant shall obtain prior written consent from any other third party such as wedding venues, wedding photographers, event planners, celebrity performers etc and as required by NDTV Lifestyle before the shoot commences. In the event the bride, groom or their parents do not give written consent, the Applicants right to participate shall be automatically deemed to have been cancelled.
- 9. IN THE EVENT IT WOULD NOT BE POSSIBLE FOR AN APPLICANT TO ADHERE TO THESE CONDITIONS (OR ANY OF THEM) IT IS STRONGLY ADVISED THAT THEY SHOULD NOT APPLY / REGISTER FOR THE SHOW.
- 10. Applicant undertakes not to, for any reason whatsoever, withdraw from the Show or any part thereof except in accordance with Rules and/or by the written approval of the Company. In the event, Applicant withdraws from the Show, this declaration shall hold valid for Applicant's participation, in addition to payment by way of compensation from Applicant side to the Company, for any loss occasioned by the Company due to these acts of Applicant.
- 11. Applicant recognizes and acknowledges that the Company and its partners/sponsors/advertisers have invested substantial resources for the production of this Show and its promotion. Applicant also acknowledges that a breach of his/her obligations herein may cause substantial and irreparable harm to

the Company and its goodwill and image, including its partners/sponsors/advertisers. Accordingly, in case of any breach by Applicant, of the terms and conditions contained herein (including abandoning the shooting of the Show at any stage without written consent of the Company), the Company shall be entitled to take appropriate and stringent action against Applicant, including but not limited to claiming monetary damages, in addition to such other contractual, legal or equitable remedies as may be available to it. Notwithstanding and without prejudice to any rights the Company may have against Applicant, in the event he/she refuses to shoot with the Company after agreeing to the same earlier (in which the case the Company stands to suffer substantial damages on account of having made arrangements to shoot with Applicant), Applicant shall be liable to reimburse a sum of Rs.5,00,000/- (Rupees Five Lakh) as liquidated damages to the Company within 7 ( seven ) days of such shooting date. Applicant acknowledges that these sums are a fair assessment of damages suffered by the Company in case of his/her failure to adhere to his/her commitments as stated above and Applicant shall pay the same without any demur, protest or challenge.

- 12. The entire copyright and other intellectual property rights in the said Show and all footage shot for this Show (including footage featuring the Applicants/participants) shall vest with NDTV Lifestyle. NDTV Lifestyle has the sole & exclusive right to exploit the footage of this Show commercially by and all means throughout the world and shall have the right to edit, cut, translate, dub, package or alter the footage, and to combine it with any other material for that purpose. NDTV Lifestyle is authorized to use the footage recorded for this Show and any material including photographs/videos submitted by the Applicant in any manner it deems fit, including for broadcast on its channel or any other third party platform, and the Applicant cannot hold any claim against NDTV Lifestyle in this regard.
- **13.** The applicant understands that the footage shot by the NDTV Lifestyle team, will not be made available or shared with applicant.
- **14.** The decision with respect to selection / non selection of an Applicant as a participant in the Show shall be decided by NDTV Lifestyle in its sole discretion. Mere registration as an Applicant does not entitle participation in the Show.
- 15. The designer and any other expert chosen for the Applicant and the other participants are entirely on the discretion of NDTV Lifestyle. The Applicant will have to wear the outfit and jewellery selected by the design partners and the Applicant shall return the outfit and jewellery in the same condition as taken on the same day, after commencement of shoot. NDTV agrees that the applicant will retain one outfit given to the bride and one outfit given to the groom. Items to be retained by the Applicant is entirely on the discretion of NDTV and its partner sponsors. Applicant agrees to endorse sponsors as directed by NDTV Lifestyle.
- 16. The jewelers would be providing genuine gold, diamond, precious stone studded and jewelry (as the case may be), from their showroom/s, to the participants/brides for the limited purpose of wearing/using at the wedding function/ceremony/ceremonies during the show. An authorized representative of the jewelers will carry/bring the said jewelry with him/her to the Show and remain present, during the show, from the time of handing over the jewelry to the Participant/Bride and to the time of receiving back the same from the Participant/Bride.
- A. The authorized representative of the jewelers will hand over the Jewelry, directly to the Participant/Bride only, during the course of the show. The jewelry will be handed over on a strictly returnable basis. The jewelry will be handed over to the Participant/Bride on written and signed confirmation from the Participant/Bride towards receipt of the said jewelry.

- B. The Authorized Representative will collect the jewelry back from the Participant/Bride and on receiving back the jewelry, the authorized representative will, in the presence of the Participant/Bride, inspect and fully satisfy himself/herself that the said jewelry is intact/complete/non damaged and in the same condition in which the jewelry was handed over to the Participant/Bride. There shall be no liability or responsibility of any kind with regard to the Jewelry of/on the Company.
- C. Once the jewelry is handed over to the Participant/Bride there shall be no liability or responsibility of any kind with regard to the Jewelry, the jewelers and the Participant/Bride shall be entirely responsible for the proper care and safe custody of the jewelry till the time it is handed back to the authorized representative of the jewelers. The Participant/Bride will make every effort to take proper care of the jewelry whilst it is in her custody.
- D. The jewelry while in the custody of the Participant/Bride, will continue to be the exclusive property of the jewelers company only and the Participant/Bride will only have the privilege to wear/use the jewelry during the show only and
- E. neither the Participant/Bride nor any third party shall have any claim, whatsoever, on the jewelry.
- 17. The Show team shall be given full access to the wedding venue. If any army/defence service's or any other such shooting permission(s) are required, then the Applicant has to organize and procure such permission(s) for NDTV Lifestyle so that the shooting to take place. In case of any additional venue costs , same shall be borne by the Applicant.
- **18.** The Show team shall be entitled to shoot in and around the Applicant's home and the house of the bride and groom/in-law's/the groom's house. In case any permission(s) are required to be taken for the same, the Applicant will be solely responsible for procuring the same.
- **19.** The schedule and location for the Show Shoot / Promotional Activity shall be communicated to the Applicant reasonably in advance and the Applicant shall abide by it.
- **20.** Once an appointment is set, the Applicant shall ensure that the bride and grooms family and their future in-laws make themselves available at the appointed time and place, to the Show team to shoot at the said location.
- **21.** On the day of the wedding, the Applicant/bride to be and bridegroom and all family members need to adhere to the schedule and make themselves available to the Show team as mutually decided upon.
- **22.** Any objections on time and date of shoot (commitment of date) is to be informed to NDTV Lifestyle at least 15 days in advance and in writing before the shoot starts.
- 23. The Applicant understands that the Show team fixes up appointments with designers, celebrities, other distinguished persons for the purpose of shoot only after getting a confirmation from the Applicant with respect to the date and time. The Applicant will ensure that they and the bride and groom, their family and their future in-laws will adhere to the committed timelines.
- **24.** Incase of a makeup partner, the participants will be required to ask their makeup artist to use the makeup brand on board. The makeup artist will be required to showcase the products of the makeupsponsor.

- **25.** The Applicant agrees to abide by all rules and / or terms and conditions as prevailing or changed from time to time by NDTV Lifestyle in its sole discretion.
- **26.** In case the Applicant or the Applicant's immediate family or future in-laws family are related to any person employed in any of the NDTV group companies, or any of the judges as informed to the applicant at any stage, the applicant must disclose the same immediately to NDTV Lifestyle Team.
- **27.** NDTV Lifestyle is not responsible for any delays or non-receipt of applications on any account and for any reason whatsoever. NDTV Lifestyle reserves the right to reject any application without giving any reason. No objections in this regard will be entertained.
- **28.** The Applicant undertakes that during the shoot of the Show, they shall behave in a professional manner with fellow participants and crew members and shall maintain strict decorum.
- **29.** NDTV Lifestyle shall not be responsible for any loss or physical injury that occurs to the Applicant and the participants on account of their participation in the Show. The Applicant and all participants will participate at their own risk and can have no claim whatsoever against NDTV Lifestyle.
- **30.** The decision of NDTV Lifestyle is final in all cases. No queries or objections will be entertained in this regard.
- **31.** NDTV Lifestyle shall not be responsible for non-completion / non-occurrence of the Show as planned, force majeure conditions included.
- **32.** In case of any dispute, only the courts at Delhi will have the exclusive jurisdiction to entertain the same. Kindly acknowledge and sign a copy of this letter as a token of your acceptance of the same. (to be signed by bride and groom, both)
