## TERMS & CONDITIONS TO AVAIL FUNDS TOWARDS QUARANTINE OF STUDENTS STUDYING ABROAD

- 1. The terms and conditions contained herein (hereinafter referred to as "**Terms**") apply to the Indian students travelling abroad who require financial assistance to pay for the quarantine facility as per the individual requirements of the Country they intent to study in (hereinafter referred to as the "**Campaign**").
- 2. Your participation in the Campaign will be construed as an acceptance of the Terms. If you do not agree to any of the Terms you should not participate in the Contest.
- 3. Sanmat reserves the right to modify the Terms at any time.
- 4. This Campaign will commence on August 3, 2021 and will end on August 24, 2021.
- 5. The Campaign is open to Indian students studying in universities and colleges around the World.
- 6. Employees of NDTV & its subsidiaries/group companies as well as those companies & their subsidiaries sponsoring the Campaign and their families are not eligible to participate in the Contest.

## **RULES OF PARTICIPATION**

- 1. The students scheduled to travel abroad for their university courses shall be eligible to participate in the Campaign and avail financial assistance from Sri Someshwar Nath Mahadev Trust ("Sanmat") for the amount determined by Sanmat at its sole discretion.

The students shall be selected by Sanmat to avail financial assistance on a first come first serve basis as per the information provided by the students. The preference shall be given to the students who have taken loans or have got scholarships for studying abroad.
- 3. Sanmat shall contact the selected student within 7-10 working days after he/she has been chosen to avail financial assistance. The selected student will have to provide his/her identity proof and complete contact details to Sanmat. Sanmat may require the selected student to produce any other document at its discretion in order to confirm his / her details before the financial assistance is granted.
- 4. Sanmat shall make reasonable efforts to confirm the identity of the selected students before providing the financial assistance. However, if the verification of the identity of the selected student is not possible due to any reason(s) including but not limited to, the inability to contact the selected student, submission of incomplete documents, or any other reason beyond the reasonable control of Sanmat, Sanmat shall be entitled to forfeit the grant and select an alternate student in his place.

- 5. Mere submission of the application does not entitle you to avail financial assistance.
- 6. NDTV & its subsidiaries/group companies reserve the right to cancel / postpone /stop this Campaign at its discretion or change all or any part of terms and conditions that are applicable, without giving prior intimation of any kind and being liable for any consequential losses/damages.
