## Annexure A

S.No.	Particulars	Details
1.	Brief details of litigation	RRPR Holding Private Limited ("RRPRH"), the Promoter Company, received two reassessment notices from the Deputy Commissioner of Income Tax ("DCIT") under Section 148 of the Income Tax Act, 1961 ("the Act") - one on August 8, 2014, for Assessment Year 2009-10, and another on March 23, 2015, for Assessment Year 2010-11.
		RRPRH challenged these notices before the Hon'ble Delhi High Court via Writ Petition Nos. 1663 of 2016 and 1664 of 2016.
		The Hon'ble Delhi High Court granted an interim stay on February 26, 2016 on the reassessment proceedings for both the Assessment Years. This stay was made absolute by the Hon'ble Delhi High Court on August 17, 2017.
		However, on October 25, 2017, the DCIT passed a Provisional Attachment order under Section 281B of the Act, attaching 1,88,13,928 shares of the Company held by RRPRH.
		Thus, RRPRH filed another Writ Petition No. 10063 of 2017 with the Hon'ble Delhi High Court, inter alia, to quash this attachment order.
2.	The details of any change in the status and/ or any development in relation to such proceedings.	The abovementioned Writ Petitions filed by RRPRH has been allowed by the Hon'ble Delhi High Court vide an order dated September 10, 2024, thereby quashing the reassessment orders for the Assessment Years 2009-10 and 2010-11, as well as the consequential provisional attachment order. Order received on September 13, 2024 at 2:58PM.
3.	In the case of litigation against key management personnel or its promoter or ultimate person in control, regularly provide details of any change in the status and / or any development in relation to such proceedings.	The abovementioned Writ Petitions filed by RRPRH has been allowed by the Hon'ble Delhi High Court vide an order dated September 10, 2024, thereby quashing the reassessment orders for the Assessment Years 2009-10 and 2010-11, as well as the consequential provisional attachment order.
