

Existing and new FPIs will

have three months to bring down their holding below these thresholds, failing which they will be required to make additional disclosures. This has been done to guard against possible circumvention of Minimum Public Sharehold-ing (MPS) porms or disclosures. Minimum Public Sharehold-ing (MPS) norms or disclosures under Substantial Acquisition of Shares and Takeovers Regu-lations, 2011, and/or possible misuse of the FPI route to cir-cumvent the requirements of Press Note 3.

Applicants with investors contributing 25% or more in the corpus that is mentioned
